2008 SPONSOR'S AGREEMENT FORM**

Team sponsorship is **\$450.00** for team uniforms and expenses. Teams have a minimum 12-player roster with a ten to twelve game season, which may include tournament play.

Team sponsorship is **\$450.00** per team for one season to be paid by the sponsor. Said team shall be entitled to participate in authorized league activities during 2008 season. Games to be played during the season shall be between 10 and 12. Games will be played at Weslaco City Park and out of town. It is mutually agreed that the sponsor's participation in the league is limited to that of a financial contributor only. That the payment of the above amount shall satisfy all obligations and responsibilities on the part of the sponsor and that no liability is assumed by the sponsor for any risk and hazards incidental to participation in the league by the players, volunteers, leaders, workers, spectators, or others associated with the league. The sponsor agrees that selection of players for the team, managers, and coach personnel to direct the team shall be the sole responsibility of the designated league official. The sponsor further agrees that no additional funds, solicited or unsolicited, will be expected for this team without the consent of the Director of the league.

Sign sponsorship is **\$475.00** for a three year commitment. Sponsors sign is 4' x 8' plywood that will be placed on the out field of one of our two fields. Sponsorship signs will be located at Weslaco City Park for one season. Please include artwork for the sign with colors preferably a business card.

Plan A - Three years in full. **\$475.00**

Plan B - **\$175.00** for the first year, **\$150.00** for the second year and **\$150.00** for the third year.

Team and sign sponsorship is **\$525.00** for one year. However, the sign sponsorship is still a three year commitment. If you decide not to be a team sponsor the following year, you are still required to pay **\$150.00** for the second year and **\$150.00** for the third year of the sign sponsorship.
